## APPLICATION FOR MEMBERSHIP

Cranford Sports club Ltd is a company limited by its guarantee. This means that it does not have shares or shareholders, but instead it has members, its day-to-day management is carried out by the directors, but by becoming a member you will be entitled to do the following things:

- to attend and vote\* at general meetings; normally there will be one meeting per year, called the Annual General Meeting or AGM and you will be given at least three weeks notice of the place and time of the meeting. We may also need to call other general meetings in exceptional circumstances.
- to receive the annual accounts of the company
- to elect directors by voting\* at the meeting
- to vote\* on any fundamental changes to the nature of the company, its name, its purposes or what happens to its profits.

*\*Only Full Club Members are entitled to vote. Other adult members are 'restricted members' in accordance with the Memorandum & Articles of Association, Junior Members and Restricted Members may attend General Meetings but may not vote.*

You will not be entitled to receive any individual or other income from the company.

If the company makes a profit this will be retained to help pay for the company's activities in the following years. If the company is wound up, any assets left after all its debts and liabilities have been settled will be distributed to another local community sports club or sports governing body.

The constitution is made up of the memorandum and the articles and the rules. The memorandum sets out what the company can do and why it exists; and the articles deal with the holding of meetings, the admission of members, the election of directors and other rules relating to the running of the company. These are legal documents that are registered on the public records for the company held at Companies House. They may also be inspected at the Club, where you may also inspect the rules made by the company to date.

By signing this application form you are applying for membership of the Cranford Sports Club Ltd and agree, subject to the provisions of the Memorandum and Articles of Association of the Company and to the Rules, to pay to the company an amount of up to £1 if the company is wound up while you are a member or for up to 12 months after you have left the company. You also agree to pay any membership fee levied in accordance with the Company's Rules. Your membership will be for 12 months and may be renewed annually on full payment of the subscriptions determined by the board of Directors or by any other method of payment approved by them.

The Cranford Membership card(s) and TGS Key(s) are issued by and remain the property of The Cranford Sports Club which reserves the right, at any time without notice, to decline to issue Membership card(s) and TGS Key(s).

Should you wish to cancel your membership with the club you must return both membership card and TGS Key or you will be subject to a £15 administration charge.

Your application is subject to approval by the board of Directors whose decision is final and shall not give rise to dispute.

**\*To qualify for the money back guarantee you must do the following;**

Attend the club at least 12 times (including completing our service plan i.e. workout 1/2/3, goal setting and programme pick up and/or attend at least 4 coached/instructed sessions i.e. Bodycombat or Adult Beginners for tennis/badminton) within your first 4 weeks (28 days after your join date).

Please note; this money back guarantee is only applicable to **new** Adult subscriptions (excluding Social membership) committing to a 12 month membership.
